LEGAL BASIS FOR REJECTION

Chapter XIV The course of examination and evaluation of bids, point 1.1a of the Inquiry No. W8/382/2023/03/1 "the content of the offer does not correspond to the content of the inquiry".

JUSTIFICATION

Contractor Panewrońska Univerzita a.s. Spalena 76/14, 110 00, Praha 1, NIP: CZ699003257, within the deadline for submitting offers, sent the offer to the Contracting Authority, together with Appendices No. 3 and No. 4, signed with an illegible signature, which prevents the Contracting Party from unambiguously identifying the person signing the offer and its authorization to perform this action.

In accordance with the provisions of Chapter VIII. FORM OF SUBMISSION OF DOCUMENTS pt. 10 "The bid together with all attachments must be signed by the person(s) authorized to represent the Contractor or a proxy authorized to represent the Contractor, the original power of attorney or a copy certified by a notary public should be attached to the tender." At the same time, the provision of point 2 lit. b) Chapter VIII. FORM OF SUBMISSION OF DOCUMENTS indicates that "an offer submitted in electronic form - in the form of a scan of documents, should be signed with a handwritten legible signature or an illegible signature or initialed with a personal seal, thus enabling the Contracting Authority to identify the person authorized to represent the Contractor."

Thus, the initial made by the Contractor on the Bid Form and other procurement documents without a personal seal prevents the Contracting Authority from establishing the person by whom the bid was signed and whether this person is the person authorized to perform this activity.

Contractors excluded from the procedure (provide factual and legal justification): -----

The contractor whose offer has been selected as the most advantageous is obliged before signing the contract:

- a) The Contractor concludes the contract at the place and time indicated by the Contracting Authority.
- b) If an offer submitted by Contractors jointly applying for a contract is selected, the Contractor is obliged to provide a copy of the agreement regulating the cooperation of these Contractors before concluding a public procurement contract.,
